#### **Dr. Dicki Kennedy - Animal Rehab and Acupuncture**

Dr. Dicki Kennedy will be our guest speaker for the October 15<sup>th</sup> GKC meeting. Dr. Kennedy is the owner of the Animal Rehab and Conditioning Center (ARCC) in Simpsonville, SC. She will speak on Animal Rehab and Acupuncture. Dr. Kennedy is a veterinary practitioner of pain management, acupuncture, and has certifications in massage therapy and chiropractic. She is also a Certified Canine Master Trainer.

Dr. Kennedy graduated from the University of Georgia with her DVM, then served for five years as chief of staff in a corporate veterinary hospital, and four years as the owner of a general practice veterinary clinic in Greenville. In 2013 Kennedy founded Animal Rehab and Conditioning Center, the first veterinary rehabilitation and pain management facility in Upstate South Carolina.

ARCC offers an array of physical therapy, pain management, and conditioning services for canine athletes, sporting and working dogs, and injured or older pets focusing on the quality of life for dogs. Treatments include Class IV laser therapy, ultrasound, pulsed signal therapy, electrical stimulation, massage, acupuncture, and chiropractic. Canine conditioning equipment includes Oasis underwater treadmill, land treadmill, Vet System whirlpool, PetSafe Stance Analyzer, and FitPaws options.

## **GKC RALLY TRIALS**

Greenville Kennel Club's Rally trials were held at Happy Dogs Training Center on September 21st and 22nd. There were three trials over two days giving exhibitors an opportunity to earn a new title over the weekend. Connie Parrish of Gordon, Georgia was our judge.

As has become our custom, we provided exhibitors with a traditional BBQ lunch on Saturday. We received many compliments about our hospitality, the venue and three well-run trials.

Two of our exhibitors earned Rally Championships over the weekend. Debbie McNamee of Aiken, earned a RACH 2 with her Golden Retriever, Hope. Danielle Daws earned a RACH with her All American, Rabbit. We celebrated their wins with a RACH cake provided by Danielle's husband.

As usual, our trials filled with a waitlist within a week of the opening date. There were 54 exhibitors, 74 dogs and a total of 226 entries. Thirty-four different breeds were represented, from a Dachshund to a St. Bernard and everything in between. We had a few rare breeds that are rarely seen in any AKC venue, a Teddy Roosevelt Terrier, Cane Corso and a Yakutian Laika (I had to look that one up!). Eight Champions of Record competed.

Once again, GKC's Rally trials went off without a hitch due to the efforts of GKC and Happy Dogs members who volunteered to help us.

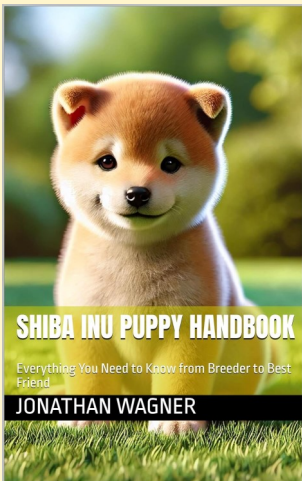
