

## New or Amended Greenville Kennel Club Policy

The board adopted a new policy in February to improve communications and transparency for the membership:

• Every new or amended policy will be sent to the newsletter editor to post in the newsletter before the membership meeting. Once posted in the newsletter the new policy(s) will be presented to the membership at the next membership meeting for questions and comments. (BOD 02/04/25)

#### Changes implemented so far this year:

- 1. Board meeting minutes are to be emailed to each Board member to review seven (7) days after the Board meeting. Board members are to respond with any correction to the Recording Secretary seven (7) days from receiving minutes. Board members are to send any agenda items for the agenda five (5) days before the Board meeting to the Recording Secretary to be included on the agenda. Dates may be adjusted for the Recording Secretary if any emergency arises. It is each Board members responsibility to have minute correction and agenda items to the Recording Secretary on time. (BOD 02/04/25)
- 2. Treasurer's Reports shall not be published in any meeting minutes. The Secretary shall include the following statement in place of the actual report "A hard copy of the report given by (Treasurer's name) is attached to the minutes in the Secretary's book and is available for all members to view upon request". The Treasurer shall provide a hard copy of each month's report which shall be retained with the minutes in the Secretary's legal record book in accordance with the club's official record retention policy. (02/04/25) This has been a long standing policy that was never documented.
- 3. Dogs owned or co-owned by the Show Chair, Assistant Show Chair, Members of the Judges Selection Committee, President, Treasurer and the AKC Delegate will not be shown during our cluster except for Junior Showmanship classes. (BOD 10/03/23) (BOD 08/06/24) (BOD 02/04/25) Amendment made to allow dogs owned by restricted members to be shown in Juniors and to apply restriction to the entire cluster.
- 4, All payments from GKC Club accounts that are greater than \$5,000 shall be approved prior to issuance of funds by the club Treasurer. This approval shall consist of a voucher signed by two current members of the board of directors other than the Treasurer; at least one of whom shall be an Officer of the club. This amount may be adjusted annually by the board in compliance with GKC bylaws. ( $BOD\ 02/04/25$ )
